### NEBRASKA FUEL TAX RATE

The third quarter 2021 (July 1, 2021 through September 30, 2021) fuel rate is \$0.2770. The rate for the fourth quarter 2021 (October 1, 2021 through December 31, 2021) will be \$0.2770.

### IT'S RENEWAL TIME

Your IRP and IFTA renewal packet is in the mail. The UCR renewal postcard will be mailed the week of September 27<sup>th</sup>. As a reminder the UCR registration is completed on-line at [www.ucr.gov](http://www.ucr.gov). If you do not receive the renewals, contact our office.

### **Renewal compliance dates:**

- UCR January 1, 2022
- IRP February 1, 2022
- IFTA March 1, 2022

### NEW ON-LINE FEATURE – ADD IFTA TEMPORARY

If you need an IFTA decal but the truck is already on the road, request an IFTA Temporary on-line to stay compliant. Access the new feature at <https://dmv.nebraska.gov/services>, click Motor Carriers Trucking, and IFTA Services. One decal per truck/year is allowed and is good for 30 days.

After you process the IFTA temporary, click on the tab Request Additional Decals. The decal will be mailed to you the day you process if it's before 3:00pm. If you would rather send in the request and payment, mail the \$1.00 (per set) and your request to our office. Remember to include your company name and account number.

### FROM THE AUDIT DESK

If you purchase extra IFTA decals during the year that are not used on your vehicle(s), the unused decals **must** be kept for audit purposes. Keep the unused decals for four years, which is the same requirement for all IFTA records.

It is a good idea to inventory the decals if you have a larger fleet and keep track of which unit has each decal (each set of IFTA decals has a unique serial number).
