FOOTNOTES

NEBRASKA FUEL TAX RATE

The third quarter 2022 (July 1,2022 through September 30, 2022) fuel rate is \$0.2480. The rate for the fourth quarter 2022 (October 1, 2022 through December 31, 2023) will remain at \$0.2480.

TAX HOLIDAY

Connecticut has extended the tax holiday on Gasoline (GA) and Gasohol (GH) though November 30, 2022. If you purchased either GA or GH during the third quarter (July 1, 2022, through September 30, 2022), you will report 0 (zero) gallons in the tax paid gallons column as you did not pay fuel tax at the pump. The gallons purchased for GA and GH will be entered in the "Other" line.

NEW JERSEY REFUND

The second quarter 2022 tax rate reported by New Jersey (NJ) was corrected by NJ after the returns were printed. If you recalculate the NJ tax rate and overpaid, you may request a refund by completing the NJ refund application. Contact NJ at 609-633-9400 (opt 1) or their email address at mcscustomerservice@mvc.nj.gov. for the new rate as it pertains to your fuel type.

NEW YORK

Travel in New York will be taxed at .3955 cents for the entire quarter, but you will reduce the tax paid gallons purchased per the instructions below:

Use the correct percentage in the table below to calculate the gallons of taxed fuel for the July 1 – Sept 30 period. Multiply the gallons purchased by the percentage below. The difference between the actual gallons purchased and the qualified tax paid gallons will be entered as "Other". HIGH/LOW MPGs

Before you submit an IFTA return on-line or file a paper return, please review the quarterly unit MPGs to verify that they are reasonable. In general, MPGs below 3.00 or over 8.00 on a unit level should be questioned and rechecked. This could indicate either a mileage or a fuel miscalculation. If you are entering your return online make sure that the calculated MPG matches your records prior to confirming.

RENEWAL SEASON BEGINS OCTOBER 1ST

The IFTA and IRP renewals will be mailed at the end of September. Don't forget we offer on-line filing for both renewals, as well as the quarterly returns. All three options can be found at https://dmv.nebraska.gov/services under the heading Motor Carriers Trucking.

UCR renewal post cards will be sent in late September, you can file online beginning October 1 at www.UCR.gov.
