NEBRASKA FUEL TAX RATE

The third quarter 2019 fuel rate (July 1, 2019 through September 30, 2019) is \$0.2970. The rate for the fourth quarter 2019 (October 1, 2019 through December 31, 2019) will be \$0.2970.

2020 UCR REGISTRATION

As of the printing of this newsletter, the 2020 UCR registration period is delayed. The Federal Motor Carrier Safety Administration (FMCSA) is in the process of completing their final rulemaking on the registration fees.

Our office will send a postcard once the registration fees are finalized and processing can begin. The postcard will be your notice it's time to file, and as a reminder, there is not an application to fill out and send in. You are required to log into the UCR website to file and pay at www.ucr.gov

ALABAMA SPLIT RATE

Alabama has a split rate for the third quarter. The first line on the Diesel Only schedule is from July 1, 2019 through August 31, 2019. The second line is from September 1 2019 through September 30, 2019. If you use fuel other than diesel the split rate applies. The on-line return will direct you to the appropriate fuel types and time frames.

FROM THE AUDIT SECTION: ORIGIN/DESTINATION INFORMATION

Mileage records must list the origin and destination for each trip or day in the form of a city or town. If you start and end the trip or day at the same location, you must also list load & unload locations. Customer names, work sites, etc. are not acceptable. If the origin/destination is not a specific city or town, the nearest city or town must be listed, including the distance from that origin/destination to that nearest city or town.

ON-LINE FILING

Don't forget we offer on-line filing for the quarterly IFTA returns, as well as the IRP and IFTA renewals. All three options can be found at <https://dmv.nebraska.gov/services>. Click on Motor Carriers Trucking. The third quarter 2019 return and both renewals for registration year 2020 will be available beginning October 1, 2019.
