NEBRASKA FUEL TAX RATE

The fourth quarter 2019 fuel rate (October 1, 2019 through December 31, 2019) is \$0.2970. The rate for the first quarter 2020 (January 1, 2020 through March 31, 2020) will be \$0.2930.

NEW TITLE SYSTEM

On October 15, 2019 the Department of Motor Vehicles implemented a new vehicle title and registration system statewide. The new system was deployed in all 93 counties as well as here in the Motor Carrier Services (MCS) Division.

The new system performs more validation checks and positions the agency to take advantage of future growth and changes in technology. With the increased validation the system performs and as the division learns to manage the various tasks, we ask for your patience if you experience delays in the title/registration of your vehicle.

RECORDS RETENTION

All original mileage and fuel records used to support the IFTA returns must be retained for four years. All mileage records used to support the IRP renewals must be retained for five years. This includes D.O.T. logs and raw data GPS records if you are using them as your mileage source documents for IFTA and IRP. In addition, we recommend making copies of fuel receipts printed at the pump (shortly after the fuel purchase), since the ink on some of these receipts fade over time.
