## NEBRASKA FUEL TAX RATE

The first quarter 2020 fuel rate (January 1, 2020 through March 31, 2020) is \$0.2930. The rate for the second quarter 2020 (April 1, 2020 through June 30, 2020) will be \$0.2930.

#### MCS COVID-19 UPDATE

Due to the current events surrounding the Covid-19 virus, the State of Nebraska is monitoring the direction given by our government leaders. With changes occurring so rapidly, we are strongly encouraging all who are eligible, to file their IFTA return online for your first quarter IFTA return and if applicable, pay the IFTA balance.

If you are a new carrier and filing your return for the first time, you will not be able to use the on-line return and will be required to send in the paper version mailed to you.

- Click IFTA Services
  - o If you need help, you can send an email by clicking on the Contact button in the upper left on your screen.
- Click Access IFTA Services
- Enter your Carrier number

The next two entries authenticate you as the owner associated with your carrier number:

- Enter your Federal ID number
- Enter your Nebraska miles filed on the previous quarter filing.
- Verify your contact information and make changes as necessary.
- Enter the return information (miles travelled and fuel purchased per jurisdiction)
- Click Submit Return

Once the return has been entered, the option to pay can be found under the heading Pay IFTA Balance.
