




# NEW NEBRASKA DRIVERS LICENSE

The new design features images of the Nebraska State Capitol in Lincoln and the Jail and Courthouse Rocks near Bridgeport. On the reverse side there are Nebraska's iconic sandhill images of cranes. In addition to the aesthetic changes, the new documents also feature bolstered security, protecting identities and reducing counterfeits. The new design was unveiled at a press conference at the Metro West Driver Licensing Office in Omaha in June.

# AAMVA AWARDS



The Nebraska Department of Motor Vehicles received an International Award from the Association of American Motor Vehicle Administrators (AAMVA). The award was in the "Improvement Through Efficiencies" category and recognized the department's launch of the Fleet eServices program. The program is an online portal for businesses to manage their fleet of vehicles and submit required paperwork for their fleets online. The department also received the regional level award in the same category.

Additionally, the Nebraska DMV received a Regional Award in the "Excellence in Government Partnership" category. The award was given jointly to the Nebraska DMV and Nebraska State Patrol for their collaborative Intelligent Roadside Operations Computer (iROC) system. The system is capable of logging important information about passing trucks at several key points on the Interstate in Nebraska, and can alert NSP officers to vehicles in need of additional screening while allowing vehicles in compliance to pass without stopping at a weigh station.











# RETIREMENTS

Several long-time DMV teammates said their goodbyes in 2021. Two of those teammates were Kathy Van Brocklin, who spent more than 45 years at the DMV, and Paul Cockson, who served the state for more than 44 years. # ADMINISTRATION

The Administration Division provide overall assistance to the operations of all divisions within the Department of Motor Vehicles. The Nebraska DMV is charged with the administration and enforcement of motor vehicle regulations and education of vehicle operators. The DMV ensures licensed drivers meet the eligibility requirements for operating a motor vehicle and those vehicles are properly titled and registered. An additional purpose is to generate and collect revenues that support not only the services offered by DMV but also other state and local government entities. The director also serves as the chairperson of the Motor Vehicle Industry Licensing Board.

### Accomplishments:

- Implemented a new design of Nebraska
- Driver's Licenses and State ID cards.
- Hired a new project manager.
- Received more than 300,000 views and interactions on the agency's social media pages.
- Launched a teammate engagement committee.

### Goals:

- Continue to modernize agency technology systems.
- Increase public awareness and outreach.











# TRAINING

The Training Division is responsible for the coordination of training and the presentation of various classes in support of the organization's commitment to employee development. They assess and evaluate training programs for effectiveness and develop adult learning opportunities for professional growth. Major focus includes creating employee learning to ensure compliance with standards and regulations.

### **ACCOMPLISHMENTS**

- Created and implemented an online tutorial on GLA training for a smooth transition to online leave time planning.
- Conducted four supervisor seminars on the following subjects: performance reviews, de-escalation, work-life balance, and First Amendment Auditors.
- Assigned 39 modules to new DMV teammates.
- Conducted 14 two-week training sessions to new driver licensing examiners.
- Facilitated CPR and AED training to 25 examiners.

• Continue to develop and implement training that supports the agency and teammates.









# INFORMATION SYSTEMS

The Information Systems Division is responsible for the development, maintenance and support of service applications and data hosted by the DMV. With the support of the Office of the CIO and Tyler Technologies (Formerly NIC Nebraska), the DMV services are easily available online, at County Treasurer offices and at DMV locations throughout the state.

### ACCOMPLISHMENTS

- Upgrade of FileBound System to Version 7.5.
- Implement Qflow Online Appointment System.
- Migrated all DMV Employees and Vendors to utilize Multi Factor Authentication.
- Development of back-end systems to accommodate the new license plate series.
- Desktop Computer Hardware Refresh.
- ELDT (Entry Level Driver Training) Implantation.
- PRISM New Plate Production System Deployed at NDOC.

### <u>GOALS</u>

- Assess security and mitigate risks on all systems.
- Roll out of new Road Test Tablets to 170 users, including DMV staff and 3rd Party Examiners.
- Major improvements to the Online Renewal System for Vehicle Registrations.
- Upcoming changes in programming in 2023 to allow Ukrainian Nationals with proper USCIS documents to get a NON REAL ID document in Nebraska.
- Begin work on the new Drivers License Service Center in Lincoln.
- Begin work on the Motor Carriers Services Modernization Project.
- Begin working with a consultant on Driver License Services Modernization.













# LEGAL

The Legal Division performs and manages legal work for the Department to support the work of the agency's other divisions. Major focuses include preparation and support of agency legislation; preparation, review, and renewal of contracts; preparation and review of various legal documents; review of federal laws and regulations to comply with federal mandates; and conducting administrative appeals for the agency. The Legal Division handles applications for persons applying to the Board of Pardons for reprieve of fifteen year license revocations, manages certification of Safety Training Option Programs (STOP), certifies ignition interlock providers, and provides manufacturers' warranty information to the public.

#### **ACCOMPLISHMENTS**

- Revoked 5,401 licenses of persons arrested for drunk driving as part of the Administrative License Revocation Program.
- Conducted training of law enforcement officers in the process and requirements for the Administrative License Revocation Program to revoke driver's licenses of persons arrested for drunk driving.
- Promulgated rules and regulations for the DMV in compliance with the Administrative Procedure Act with input from stakeholders and department administrators.
- Drafted and finished several guidance documents for dealer automated services, commercial driver's license issuance requirements, electronic signatures for titles, and medical and vision requirements for drivers.
- Managed all other administrative hearings and appeals.
- Administered and certified the ignition interlock providers in conjunction with the issuance of the ignition interlock permit (IIP).
- Provided legal guidance on issues including the ADA, FMLA, EEOC filings, grievances, appeals, and COVID-19 related guidelines.

#### GOALS

- Preparation and implementation of the Department's legislation in 2022 including bills for federal updates and harmonization of DMV processes.
- Preparation, review, and maintenance of all contract and legal documents for the Department.

# FINANCIAL RESPONSIBILITY

The Financial Responsibility Division (FR) is the gatekeeper for denying driving privileges to unsafe drivers and ensuring persons meet all the criteria to have their driving privileges reinstated. Using driving, court and crash reports they identify individuals who cannot or will not drive safely and have their driving privileges suspended, revoked or disqualified (CDL).

The FR Division is the point of contact for the issuance of employment, medical hardship, ignition interlock, and sobriety program permits. The division manages the Ignition Interlock Indigent Fund and aids in the collection of traffic fines and child support order payments. The division also manages the non CDL State-to-State (S2S) Verification Service which is a means for states to electronically check with all other participating states to determine if the applicant currently holds a driver license or identification card in another state.

#### ACCOMPLISHMENTS

• Celebrated 6-year anniversary of "Daily Huddles" in April – focusing attention on customer phone calls, hold times, education opportunities, issues from the prior business day and celebrating successes.

- Celebrated answering 100% of phone calls offered on 12/22/2022.
- Responded to 69,435 phone inquiries with an average wait time of 45 seconds. This number reflects a little over 8% decrease from phone inquiries in 2021.
- Assisted 4,186 walk-in customers which is about an 8% decrease from 2021.
- Deployed changes to the credit card process on the DMV website.
- LB271 went into effect on 07/01/2022 allowing the Sobriety Program Permit.
- Update driver's traffic violation records, process license suspensions, revocations, disqualifications, and the subsequent reinstatements when qualified.
- Worked with insurance companies using the AAMVA process to submit SR22/SR26 insurance certifications to transition to the new process with NIC Nebraska.

• Nebraska was added to the AAMVA S2S implementation calendar for October 2023 for DHR (sending/ receiving non- CDLIS convictions and withdrawals electronically with other S2S states) and have started monthly meetings in preparation. Working on multiple data cleanup projects in preparation for the go live date.

#### GOALS

• Continue working with insurance companies to promote the electronic SR22/SR26 insurance certification service that is available to them through NIC Nebraska and completing any necessary data clean up.

• Continue working on the Driver License Issuance and Control System Modernization project and any

cleanup projects deemed necessary.

Continue focusing on updating written procedures.

# MOTOR CARRIER SERVICES

The Motor Carrier Services Division assists the trucking industry by administrating a variety of programs related to the industry which include regulating compliance with the International Registration Plan (IRP), the International Fuel Tax Agreement (IFTA) and the Unified Carrier Registration System (UCR). These programs collect and distribute fees and taxes between member states and provinces.

### **ACCOMPLISHMENTS**

- Underwent a FMCSA ITD Core Compliance Review. The final report was issued June 2, 2021, with no deficiencies or recommendations identified.
- Modified IRP registration fees from \$32 to \$35 per ton which will aid in funding a modernization project.
- Handled a significant increase in IRP and IFTA accounts (20% increase from 2020).
- Met and exceeded the number of audits required by IRP, IFTA, and UCR agreements.

### <u>GOALS</u>

- Continue work on the MCS modernization project.
- Meet and exceed the number of audits required by IRP, IFTA, and UCR agreements.
- Monitor the continuing decrease in IFTA dollars collected.

The Driver Licensing Services Division ensures person who meet Nebraska's licensing requirements are issued with a permit, operator license, or commercial driver license, and individuals who meet the identification requirements set forth in State Statue are issued a State ID Card. It is our mission to have exceptional employees deliver accurate, secure, and innovative services.

### ACCOMPLISHMENTS

- Continued to process applicants statewide offering all services including the administration of all skills testing for cars, motorcycles and commercial motor vehicles during the pandemic.
- Continued work on a new Driver Licensing System containing photo capture, electronic knowledge and skills testing and document issuance.
- Prepared for the implementation of Entry Level Driver Training, scheduled for February 2022.

### <u>GOALS</u>

- Reduce wait times at driver licensing offices.
- Implement an online paperless application form and Appointment System in the Lincoln, Omaha and Bellevue offices for all driver licensing services.

# DRIVER AND VEHICLE RECORDS

Driver and Vehicle Records (DVR) oversees multiple programs including the statewide Vehicle Title and Registration System (VicToRy), the associated online services, and the motor vehicle functions performed by the county treasurers. VicToRy is used by all 93 counties for issuance of titles and registrations and collection of the fees and taxes due for over 2.4 million motor vehicles and boats. Over \$869 million was collected through VicToRy in 2022 which was distributed to over 1,200 local and state agencies. DVR is responsible for oversight and access to the driver record database which maintains the records of 1.5 million licensed drivers and state ID card holders. The DVR Fraud Unit performs investigative work relating to vehicle title and registration fraud, driver license fraud, and odometer fraud. Motor Vehicle Fraud Investigators are certified Nebraska Law Enforcement Officers commissioned as Deputy State Sheriffs.

#### ACCOMPLISHMENTS

- Maintain the Nebraska Motor Vehicle Insurance Database.
- Manage the Electronic Lien and Title Program (ELT).
- Administer the state's license plate program including inventory control of 93 types of license plates; design, approve, and issue specialty license plates.
- Print and mail over 2.2 million registration renewal notices annually.
- Administer 177,000 handicap parking permits.
- Utilize the facial recognition process to identify and review potential matches to determine if additional investigation is required prior to driver license or state identification document issuance.
- Help Desk staff responded to approximately 68,000 phone calls.

#### GOALS

- Approved approximately 19,000 new specialty plate applications.
- Arrested 93 individuals for motor vehicle related fraudulent activities.
- DVR Help Desk staff provided application and business support for county officials and the public.
- Completed work for deployment of two new specialty plates.
- Completed work for implementation of a new license plate production system.
- Completed multiple system changes in preparation for new plate year.
- Ordered 2,443,259 license plates in preparation for new plate year.
- Provided new plate year training to county treasurers.
- Provided fraud related training to Nebraska Law Enforcement Training Academy students.
- Initiated pilot project with eight counties for use of OBD readers during inspection process.
