Nebraska Fuel Tax Rate

The first quarter 2016 fuel rate (January 1, 2016 through March 31, 2016) is .2680 cents. The rate for the second quarter 2016 (April 1, 2016 through June 30, 2016) will remain at .2680.

Requesting Additional Decals

If you add a new truck to your fleet and will register it over 26,000 lbs. or a truck with 3 axles regardless of the weight, you will need a set of IFTA decals. Carriers often forget to request the additional decal when filing the paperwork to acquire the apportioned license plate and cab card. Include a request for the additional decal with your paperwork, and include a \$1.00 per set.

If you have already secured your IRP credentials, request the additional decal in writing to our office, including your name, account number and the \$1.00 per set. If time is a factor, call our office and request a 30-day IFTA Temporary Decal permit to get you on the road today. However, don't forget to mail us the request and money prior to the expiration of the temporary as only one temporary per vehicle will be issued in a given registration year.

Dual Fuel Vehicles

If you operate units with more than one fuel type – Diesel & Compressed Natural Gas (CNG), Diesel and Liquefied Natural Gas (LNG), or Diesel and Propane, contact our office for assistance. We can provide you with instructions on how to report the miles and fuel of these units on your IFTA return. Contact us at toll-free number 888-622-1222 and ask for an auditor.
