## Nebraska Fuel Tax Rate

The fourth quarter 2016 fuel rate (October 1, 2016 through December 31, 2016) is .2580 cents. The rate for the first quarter 2017 (January 1, 2017 through March 31, 2017) will increase to .2730 cents.

## Unified Registration System - URS

The next phase of the new federal URS system, expected to take place January 14, 2017, has been delayed until further notice. This phase includes the new fee structure, filing requirements for private and exempt carrers and the elimination of MC numbers. This is a reminder to log into the new URS portal system to make sure you have access to make updates as needed. Once the next phase is rolled out, our office will be unable to process the biannual MCS 150 filing.

#### From the Audit Desk:

*Inadequate audit records:* Beginning January 1, 2017, all IFTA audits with mileage source documents classified as "inadequate" will result in a 20% adjustment to the MPG. This is replacing the standard 4.00 MPG adjustment previously required.

## IFTA, IRP and UCR Renewals

Do not delay in filing your 2017 renewals. The IRP and IFTA renewals must be in the office in order to take advantage of the grace period and to guarantee credentials by the start of the enforcement dates referenced below:

UCR - January 1, 2017 (no credential is issued)
IRP - February 1, 2017
IFTA - March 1, 2017
