# **Second Quarter 2025 Filing**

This is the first return filed in the new system and there are a couple reminders to share:

- New edit if you file non-contiguous miles (miles that do not connect stateto-state), the system will require you to make a comment to explain the reason and the MCS office will review prior to completion.
- If you have travelled in a non-IFTA jurisdiction (i.e. District of Columbia, Alaska, etc.) you will enter the miles and gallons for that specific jurisdiction.
   Prior to the new system, you placed that detail in Other Travel.
- More than one fuel type if you are a carrier filing more than one fuel type, you will be required to file a return for each.
- Penalty for late payers you are required to file the return and pay the balance on or before the due date to avoid penalty. This means even though the return is timely, if the payment is made past the due date a penalty will be assessed.

### Nebraska Fuel Tax Rate

The second quarter 2025 (April 1, 2025, through June 31, 2025) fuel rate is \$0.304. The rate for the third quarter 2025 (July 1, 2025, through September 30, 2025) will be \$0.318.

## Additional Decals and 30-Day IFTA Temporary Decal

As you request additional decals, you can also request a 30-day IFTA temporary to give you time to get the decal on the truck. You will find the temporary during the flow of requesting the decal(s). There is also a stand-alone temporary under the heading, "Other Supplements/30 Day Temporary Permit". There is an edit on the number of decals you request based on the number of trucks in your IRP fleet, or if no IRP fleet, the number of decals you have ordered in the past. MCS will approve a request that is outside this limit.
