Testing Update

End-to-End Testing is in full swing! The project's 5th group of testers are currently working in the Sandbox environment, using real paperwork from their offices. Performing transactions and activities in VicToRy with actual paperwork is allowing the testers to thoroughly test the system, bringing attention to any improvements or changes that need to be made.

We have already had over 15 testers across nine different counties participate in End-to-End Testing. These testers have been incredibly thorough, asking thoughtful questions and taking part in valuable discussions about the functionality of the system.
